
I am in receipt of the complaint notated as MUR 7594 dated April 18, 2019 and received by me on April 23, 2019.

Clay Schexnayder Campaign, a legislative campaign account registered with the state of Louisiana accepted a political contribution from Enbridge-DCP PAC on September 15, 2017 in the amount of \$500.00. Upon examination of Enbridge-DCP PAC, it was found to be a federally registered PAC with the Federal Election Commission having a mailing address in Texas. Upon further review of Enbridge-DCP PAC, it was found that all contributors which contributed to the above-named federal PAC during the last election cycle of January 1, 2017-December 31, 2018 were reported as having addresses within the United States.

Although, due to facts above it is believed that Clay Schexnayder Campaign has not violated the Federal Election Campaign Act of 1971, as amended and it accepted the contribution from Enbridge-DCP PAC in good faith, I have returned the donation to Enbridge-DCP PAC. I have attached a copy of the check from my campaign account along with a copy of the letter to Enbridge.

I feel this should rectify the complaint and therefore no further action should be taken.
