To Whom it May Concern,

This firm is legal counsel to O'Brien for Ohio, a political committee registered with the Ohio Secretary of State's office pursuant to Ohio law (hereafter "the Committee"). The Committee received a letter from the Commission regarding MUR 7594. Please find attached an executed Statement of Designation of Counsel in that matter.

The Committee received two contributions from Enbridge (U.S.) Inc. PAC (hereafter "the PAC") in the form of checks dated September 7, 2017 and March 26, 2018. The checks included an address for the PAC in Houston, TX, which is the same address listed on the PAC's Statement of Organization. The checks also included the PAC's registration number with the Federal Election Commission. The checks are drawn from a bank based in the United States. A copy of these checks are included with this letter. Based on available campaign finance reports, the PAC makes contributions to Ohio political committees and is registered with the Ohio Secretary of State's office.

Per 11 C.F.R. § 103.3(b), the PAC's contributions to the Committee do not present any genuine question as to their legality. If, in the future, the committee discovers that these contributions were prohibited by law, or if the Commission so notifies the Committee, it will refund the contributions.

Based on the foregoing, the committee believes that no action should be taken against it in the above-referenced matter. Please direct any future communications regarding this matter to my attention.
