This firm is legal counsel to Friends of Dan Ramos, a political committee registered with the Ohio Secretary of State's office pursuant to Ohio law (hereafter "the Committee"). The Committee received a letter from the Commission regarding MUR 7594. Please find attached an executed Statement of Designation of Counsel in that matter.

The Committee received a contribution from Enbridge (U.S.) Inc. PAC (hereafter "the PAC") in the form of a check dated September 7, 2017. The check included an address for the PAC in Houston, TX, which is the same address listed on the PAC's Statement of Organization. The check also included the PAC's registration number with the Federal Election Commission. The check is drawn from a bank based in the United States. A copy of this check is included with this letter. Based on available campaign finance reports, the PAC makes contributions to Ohio political committees and is registered with the Ohio Secretary of State's office.

Per 11 C.F.R. § 103.3(b), the PAC's contribution to the Committee does not present any genuine question as to its legality. If, in the future, the committee discovers that this contribution was prohibited by law, or if the Commission so notifies the Committee, it will refund the contribution.

Based on the foregoing, the committee believes that no action should be taken against it in the above-referenced matter. Please direct any future communications regarding this matter to my attention.
